Room 1: Alisa Smedley "<u>Handle with Care: Addressing Fragility in the Correctional</u> <u>Classroom</u>"

This workshop will identify the signs and causes of academically fragile students. We will examine how educators unknowingly exacerbate the situation and demotivate students right out of the classroom. Best practices for building student confidence, motivation and self-direction will be explored.

Room 2: Mike Johnson "TABE 13/14"

This session will review updates and best practices for TABE testing including Off-Line Testing, plans for TABE 13/14 and discuss the use of how TABE CLAS-E Online can support ESL programs. We will review new alignments to Grade Ranges and the Concordance of TABE 11/12 to available High School Equivalency tests. We will also explore the new TABE Workforce Portal that aligns TABE Scores to over 500 of the Bright Outlook careers posted in the US Department of Labor's Occupational Network (O\*Net).

Room 3: Jenifer Montag "Locked Out of Education: Disabled Students Who Are Incarcerated Enrolled in College Correctional Education Programs" Does your institution have a college correctional education program? Will they implement one soon? Starting in July 2023, individuals who are incarcerated will have access to PELL Grants to pay for college (U.S. Dept of Education, 2021). Maruschak, et al. (2021) states 38% of those incarcerated have a disability. College accommodations are different than high school Special Education services (IEP or 504 plans). Providing access for disabled college students who are incarcerated must be factored into any CCEP. Implementing access and inclusion for disabled college students inside the prison is extremely complex, but not impossible. Discussion and research/practice-based case studies will highlight not only the barriers inside, but more importantly, research-developed tools to navigate those barriers, and ways to help create disability access and inclusion for this doubly impacted population of students. Discussion about the differences between high school and college accommodations will be included.

Room 4: Paul Freedman "<u>Sharing Program Success: Simulator Labs for Heavy Equipment</u> <u>Operator Training</u>"

The Florida Department of Corrections (FDC) CTE Programs and Re-entry team has deployed simulator-based training at eight FDC facilities, including one program delivered in collaboration with a Florida state college. The deployment includes 5 Heavy Equipment Operations (HEO) labs and 3 Logistics (lift truck operations) labs using training simulators from Simlog that feature instructional designs aligned with standardized industry training curricula.

With the HEO programs now in their second year, this session will share key success factors and first-hand observations about the use of simulation with standardized curriculum from NCCER. An emphasis will be placed on the student/inmate experience with the simulators as they progress through practical skills development and earning NCCER credentials.

This session will explore best practices for simulator lab setup and training efficiency, including a look at cohorts that have completed FDC's HEO courses, and drawing upon details shared by one of FDC's lead HEO program instructors.

Room 5: Steven Hunt "<u>Building a Retirement Income Plan: Part 1</u>" *Provides an overview of one of Steven's retirement strategies for his clients. Discusses the difference between accumulation and distribution, the six risks of* 

retirement, strategies for creating a sound retirement income plan.

Room 2: Caleb Perkins & Noah Freeman "<u>Overcoming the Challenges of Education for</u> Adults in Custody in a Post Covid Corrections Environment"

Technology presents an opportunity to expand access to a greater breadth of learning opportunities for incarcerated people, drive process efficiencies for correctional staff, and increase the amount of time learners can be actively engaged in coursework. If done well, it needn't replace teachers or in-person access but can supplement and expand existing in-person capacity. Embracing current technology puts incarcerated learners as a distinct advantage in the job market and increases the odds of successful reintegration, but it is also a necessary component of any high quality 21<sup>st</sup>-century education. Education technology can enable correctional agencies to expand rehabilitative and programming needs, with existing staff and classroom resources. In this presentation, we will explore how correctional agencies are using the best quality digital education solutions to expand access to a wide range and breadth of course offerings for learners, while tracking their outcomes against individualized learning plans, keeping learning and vocational certificate records, and connecting people with jobs.

This session will explore best practices and techniques for using technology to support high-quality education in correctional settings. Speakers from additional agencies may also be involved as availability dictates.

Room 3: Joseph Tragert "<u>Providing Equitable Access to Premium Learning Content in</u> Correctional Education"

Room 1: Maria MacDougal "<u>Challenges and Strategies for College Counseling in</u> <u>Re-Entry</u>"

Starting or continuing college is a common goal for folks in re-entry. As part of the process there can be many barriers and challenges, especially where financing is concerned. Students are often up against prior student loan debt, balances to other institutions, an inability to complete the FAFSA and more. In this session, we will discuss some resources and best practices to support folks in reentry as they start or continue their education journey.

The New York State Department of Corrections and Community Supervision provides a supplemental education program through the Lantern Learning Management System on the incarcerated individuals' JPay tablets. The Lantern program provides a meaningful, education supplement to classroom instruction at five pilot facilities to enhance our incarcerated individuals' programming and to meet their identified educational needs. Facilities were chosen for participants, Special Education status, security level and location.

#### "How Can Tablet Education Help Improve and Expand Programming"

**Desiree Jordan** participated in the initial pilot of tablet and tablet-based programming with the NYC Department of Corrections. Managing the daily operations of distribution, provider content and reporting. She has been with Edovo for the past year managing partner relationships across the Edovo portfolio.

**David Case** was hired at Hampshire County House of Corrections a year ago when the tablets were in carts and not being utilized at all. David worked closely with the security team to get the tablets back out to the inmates starting a group known as Tablet Tuesday. David created a course in Edovo using Course Editor supporting Northstar Digital Literacy program. Prior to corrections, David worked in the private sector and vocational technical education. One keen interest though the years has been to Bridge the Digital Divide.

#### "An Introduction to ABE & ESOL: Teaching Remedial Reading, Letters, & Sounds"

**Herman Lee** is a Correctional Andragogist with over 4.5 decades of experience as an ABE, ESL, GED, and Life Skills (Substance Abuse) instructor with the Illinois Department of Corrections. In 1982 he authored a manuscript titled "<u>A Handbook for Teaching Adult Basic Education in the Department of Corrections</u>". This process manual became the school district's Adult Basic Education Language Arts Curriculum. In 1983 he was recognized as CEA Region III Teacher of the Year. Mr. Lee has been presenting papers at regional, national, and international educational conferences for more than 3 decades. Mr. Lee is a Licensed Professional Educator, Certified Alcohol and Other Drug of Abuse Counselor, Certified Criminal Justice Professional, and Certified Co-Occurring Substance Use and Mental Health Disorder Professional I.
